Re: 2010 U.S. Youth Soccer Region II Championships

This is a supplement to the packet you will receive from the Host Association.

1. The match schedule and bracket draw will be released no sooner than June 10<sup>th</sup> per Regional Policy. Please insure that each team receives a copy of this schedule. The match schedule and draw results, as well as all information in the Host Association mailing will also be posted on the Region II website, [www.Region2.com](http://www.Region2.com).
2. Registration will be held at the Dayton Marriott. A schedule of registration times is included with the LOC mailing. **It is also important to inform teams that players are not required at registration, only a coach/team manager.**
3. I am enclosing a supply of the Team Information form, Code of Conduct form, and Eligibility Form for the competition. Please make sure each team is given one of each. **These must be completed in order to register the team.**
4. **Please remind teams that LAMINATED player passes for all players and coaches will be required for registration.**
5. **Please remind teams that Medical Release forms are required for each player.**
6. **It is highly recommended that each team bring copies of birth certificates or other acceptable proof of age documents.**
7. State Representatives are asked to stay in the Headquarters Hotel (Dayton Marriott, 1414 South Patterson Blvd, Dayton, Ohio 937-223-1000). One room is held at the HQ Hotel for each State Rep and should be reserved through the Ohio South and CVB housing process. **There will be a meeting of State Reps at the Dayton Marriott at 9 pm Friday evening.**
8. A supply of the rulebooks is included in this mailing. Please make sure each team is given one of these. Please note the Policy for overtime periods is that we will play complete overtime periods in the semis and final rounds.
9. Any State that withdraws any team may be assessed a fine.

- 10.** It is very important that State Associations forward game reports, league rosters and Blue rosters to us immediately after completion of your championships. Please forward the paperwork on all Fall competitions at your earliest convenience. These must be complete and have 2 contacts listed for each team. We must receive these forms by the JUNE 10<sup>th</sup> deadline. These should be sent to **Mary Clarksen at: 1514 Sunny Circle, Waukesha, WI 53188. (THIS IS THE SAME ADDRESS AS LAST YEAR)**
- 11.** Please remember to save the game reports, League rosters and Blue rosters for teams participating in the Midwest Regional League from your State Cup competitions. These will need to be submitted (see item #10) if a team from your State Association is selected as a Midwest Regional League representative.
- 12.** Each State must submit their bond of \$ 100 per team participating payable to USYSA Region II to me by JUNE 10.
